Your W-2 form shows you how much you have owed in the whole past year and how much you have paid in taxes on those wages.. IRS W-2 Format The Form W-2 is divided into several boxes for reporting various items related to your income.. Not all of your income is subject to a social insurance tax, but only part of it, so you may find in box 3 that the amount reported is lower than your total salary for that year.

As part of the employment relationship, the employer must fill out the W 2 form for each employee who is paid wages, salaries, or other compensation.. Employers are required legally to send your W 2 copies to the Social Security Administration (“Copy A”) and local tax authorities and your state (“Copy 1”).. December 31, 2012 Form W-2 reflects all taxable wages paid to you and taxes withheld from your pay during the calendar year.. You should fill in a lot of the information into the W 2 form when you do your taxes..
